Dear colleagues,


As we look back on the past months, we can report that EMPA continues to proudly represent and defend the interests of our members on all fronts.


AMPI Conference Galway

CEF Campaign

organisations, therefore, wish to spread the message that Europe's vital ambitions and targets can only be reached if they are complemented with the necessary EU funding and investments. EMPA is again committed to the joint campaign "More EU budget for transport!".

Workshop for the Seafaring Profession





On 17 January 2024, EMPA participated in a Workshop for the seafaring profession in Brussels, organised by DG MOVE. The workshop's main aim was to discuss the following topics holistically: digitalisation, decarbonisation, social security and well-being at sea to increase efficiency and safety, improve life on board, and attract younger generations to the maritime sector.

Maritime Safety Package



On June 2023, the European Commission presented the maritime package, focused safety introducing modernised maritime safety and security rules on port state and flag state control, maritime accident investigation and ship source pollution. The package also includes a proposal to revise the Regulation of the European Maritime Safety Agency (EMSA). EMSA would be legally mandated to provide EU Member States and the Commission with technical, operational and scientific assistance to ensure maritime safety, security and the green and digital transition of the maritime sector. In the European Parliament, the Committee on Transport and Tourism (TRAN) is leading the work on this legislative file. The committee report was adopted on

7 December 2023, along with a mandate to open trilogue negotiations.

European Port Strategy



The European Parliament has adopted so-called own-initiative (nonlegislative) report by MEP Tom Berendsen calling on the Commission for an EU Port Strategy by the end of 2024. Europe needs robust ports and solid vlaque chains at its core. Furthermore, the report urges the Commission to put port workers at the centre of the digital and green transition and to make the industry more attractive to women. It stresses the need to safeguard fair and safe working conditions for all port and maritime workers. The report also underlines the risks of delocalisation of container transhipment activities to non-EU ports with the aim of evading the requirements of the EU Emission Trading System (ETS) Directive and the FuelEU Maritime Regulation.

ETS



The EU Emissions Trading System (ETS) makes polluters pay for greenhouse gas emissions and generates revenues to finance the EU's green transition. In January 2024, the ETS was extended to cover CO₂ emissions from all large ships of 5000 GT and above entering EU ports, regardless of the flag they fly. The system covers 50% of emissions from voyages starting or ending outside the EU and 100% of emissions between two EU ports and when ships are within EU ports. The ETS covers CO₂ (carbon dioxide), CH₄ (methane) and N₂O (nitrous oxide) emissions, the two latter only as from 2026.

In November 2023, EMPA, together with other European maritime stakeholders, co-signed a joint press release to urge the EU Commission to start a study about the impact of EU ETS for shipping, to express the need for a global ETS, and to explore the possibility of concluding bilateral agreements with EU neighbouring countries to adopt legislation similar to ETS. EMPA also cosigned a joint letter to DG CLIMA to raise awareness about the risk of carbon leakage and business leakage at the expense of EU ports and to request a meeting to discuss this critical topic.
